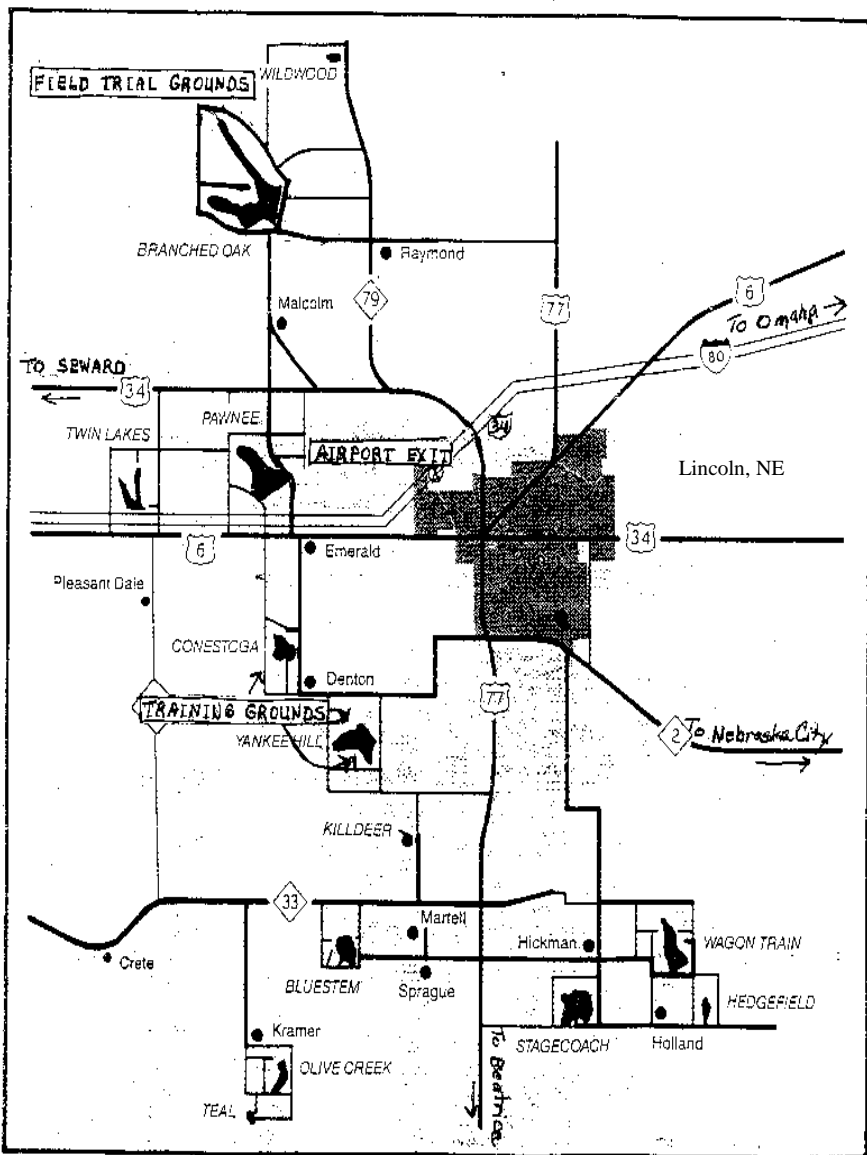


Branched Oak Dog Trial Area & Yankee Hill
